LANDSCAPE SCREENING PROGRAM:

As part of the Berrybank Wind Farm planning permit, GPG is committed to providing **all residential dwellings** within **4.0km** of an approved turbine the right to apply for landscape screening. The dwellings that will be eligible for screening will have:

- views from habitable rooms from within the dwelling and/or;
- views from the main entrance/exits of the dwelling and/or;
- artists' studios and/or;
- views from areas of outdoor private open space that are within 50m of the dwelling.

The application period for the Off-site Landscape Screening program commences concurrently with the construction of wind turbine pads and remains open for **6 months** after the final turbine has been commissioned. Construction Update

Construction has been moving **forward** at a steady pace, despite the latest lockdown. The concrete contractors have completed pouring **11** out of the 26 Wind Turbine Generator Foundations. The electrical contractors have been able to push on despite inclement weather that has occurred over the past month and have completed laying **18km** out of the 62km of underground medium voltage cables. Over the coming months, there will continue to be **traffic control** measures on the local roads at various locations around the Berrybank Wind Farm Site where there will be **upgrading works, drainage works or road crossings**. As per the Traffic Management Plan, our contractors will ensure as **little impact** to the local traffic as possible.
